Insurance Coverages

Trip Cancellation & Trip Interruption

Reimburses you for non-refundable payments and certain extra costs if your trip must be cancelled or interrupted due to injury, sickness, natural disasters, or other specified circumstances.

Travel Delay

Pays for certain extra transportation and accommodation expenses if your trip is delayed for 12 hours or more due to a covered reason.

Travel Accident

Provides coverage for loss of limb or life in the event of an accident while traveling, or within 180 days afterwards as a direct result of the accident.

Baggage Delay

If your baggage is delayed more than 24 hours, you will be reimbursed for the purchase of essential items.

Emergency Assistance (Emergency Medical Transportation)

Nurse Help Line
